

MARANA ORDINANCE NO. 2023.028

RELATING TO FINANCE; AMENDING THE TOWN OF MARANA COMPREHENSIVE FEE SCHEDULE TO CLARIFY DESCRIPTIONS OF THE PARK RENTAL BUNDLE AND SPECIAL EVENT PERMIT FEES; AND DESIGNATING AN EFFECTIVE DATE

WHEREAS the Town Council is authorized by A.R.S. § 9-240(A) to control the finances of the town; and

WHEREAS the Town Council, via Ordinance No. 2021.008, adopted an amended comprehensive fee schedule on May 18, 2021, which was made a public record by and attached as Exhibit A to Resolution No. 2021-071; and

WHEREAS from time to time the Town Council has adopted amendments to the comprehensive fee schedule, most recently on August 1, 2023, via Ordinance No. 2023.022; and

WHEREAS amending the comprehensive fee schedule as set forth in this ordinance is in the best interests of the Town of Marana.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWN OF MARANA, as follows:

SECTION 1. The Town of Marana comprehensive fee schedule adopted via Ordinance No. 2021.008, as previously amended, is hereby amended (with deletions shown with ~~strikeouts~~ and additions shown with double underlining) (only amendments to the fee schedule are shown; the remainder of the fee schedule is unchanged):

COMMUNITY SERVICES: PARKS, RECREATION & SPECIAL EVENTS			
Park Rental Bundle	500.00	Per park/Per date	Reservation of all <u>designated</u> rentable park spaces, utilities, Event Application Fee, Beer & Wine Permit. (Additional fees for liquor license may apply for public events). <u>Event Application</u> can be submitted up to 6 months in advance.

Special Event Permit – Minor less than 1000 attending	50.00	Per application	Does not apply to events where park exclusive use <u>Park Rental Bundle</u> fee is paid. Includes safety inspection, right of-way and traffic control review if applicable to the event.
Special Event Permit – Major 1000 or more attending	1000.00	Per application	Does not apply to events where park exclusive use <u>Park Rental Bundle</u> fee is paid. Includes safety inspection, right of-way and traffic control review if applicable to the event.

SECTION 2. The various town officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.

SECTION 3. All ordinances, resolutions, or motions and parts of ordinances, resolutions, or motions of the Council in conflict with the provisions of this ordinance are hereby repealed, effective as of the effective date of this ordinance.

SECTION 4. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, the decision shall not affect the validity of the remaining portions of this ordinance.

SECTION 5. This ordinance shall become effective on November 1, 2023.


