



Re: Town of Marana Pavement Preservation Program – **STREET CLOSURE**

Dear Marana Resident,

This letter is to notify you that your street has been selected for the Town of Marana's Pavement Preservation Program. This program is part of our ongoing commitment to improving and preserving high quality roads. Due to the type of work, you will experience temporary road closures while work is being performed.

KE+G Construction has been contracted to perform the street maintenance project in your area. The work involves seal coating of the streets within your subdivision. The seal coating is anticipated to take place between **May 05 to May 09, 2025**.

**\*\*\*IMPORTANT POLICIES TO NOTE\*\*\***

- **Road Closures and Shuttle Service:** Your road will be unavailable for travel on certain days. A shuttle service will be available to get you to and from your residence and vehicle. The shuttle service will run from 7:00 a.m. to 5:00 p.m. **To contact the shuttle, please call 520-653-9683.** Please refer to the attached map for details on which days your address will be affected.
- **Parking Restrictions:** The type of treatment being applied to your road requires a **24-hour period of no traffic**. **All vehicles must be parked off the street. Please park your vehicle on another street in the neighborhood that is not receiving treatment the same day your street is scheduled (please refer to the map for details).** The HOA has been notified, and temporary street parking will be allowed during the repaving project. If a vehicle is left on the street and its owner cannot be located, it may be towed. Please see map on the back for closure areas and dates.
- **Sprinkler Restrictions:** Sprinklers may not be used one full day before and after your road has been treated. Treatments cannot be applied to wet roadways; delays may occur if moisture is present 24 hours before or after treatment has been applied.
- **Trash and Recycling Pickup:** Trash and recycle containers must be kept off the street. If pickup is scheduled during construction hours, your service will occur at the next scheduled pick-up date. In the case of a life-threatening emergency, public safety vehicles will be allowed to drive on the treated surface.
- **Weather Delays:** Work cannot be performed in inclement weather. If the work is delayed due to weather conditions, you will be notified of any revised schedule or additional closures.
- **Work Hours:** Work is scheduled from 7:00 a.m. to 5:00 p.m. **You will be able to access your road after all barricades have been removed.**

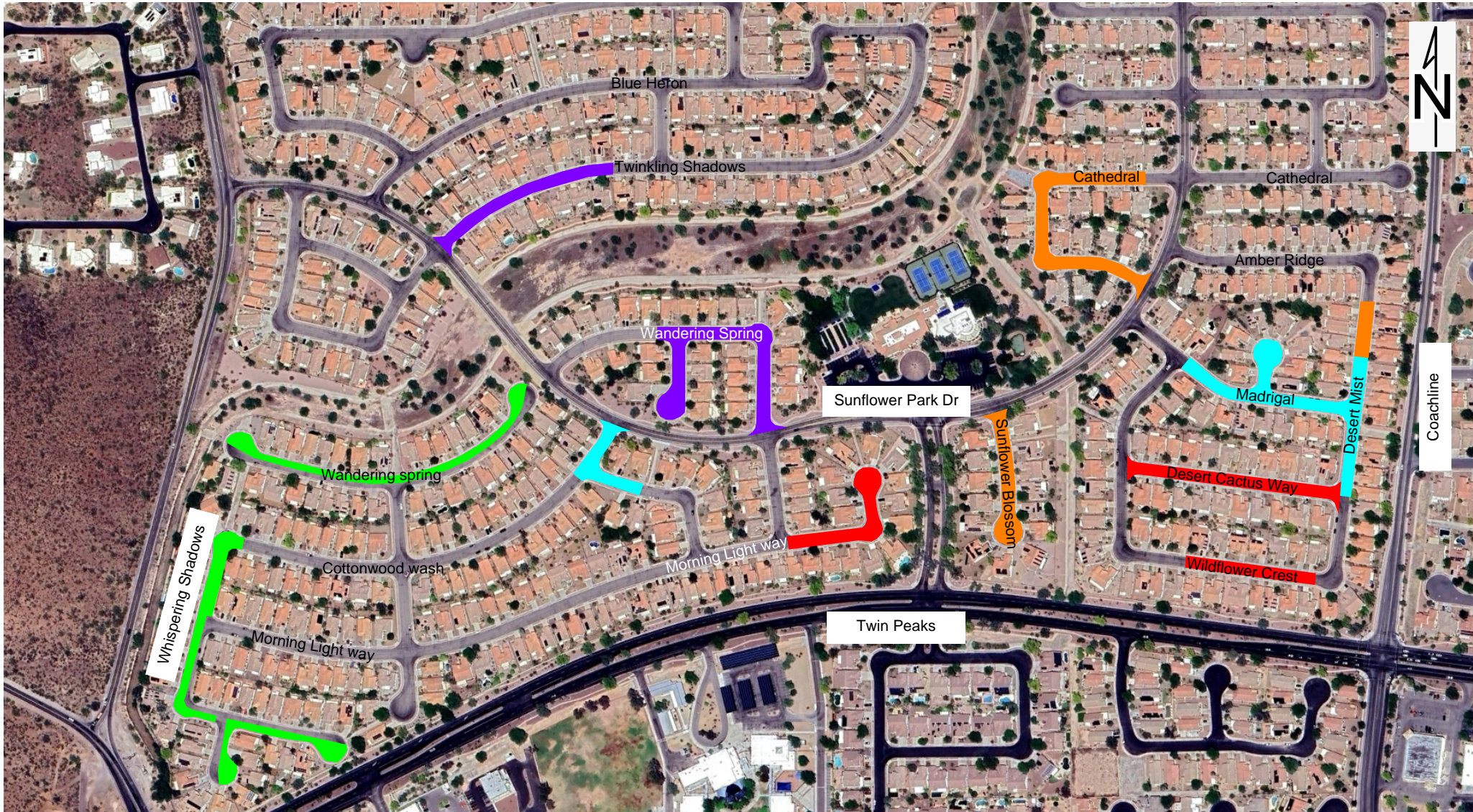
