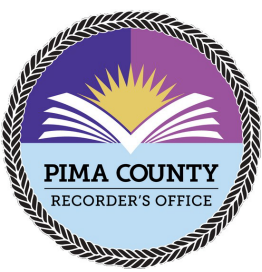

Political Party Ballot Report Unaffiliated Partisan Choices

As per A.R.S. § 16-645(B) this report shows the total number of partisan ballots by party, selected by voters registered as no party preference, independent or not one of the 5 recognized political parties. During the 2026 Primary Election, Democrat, Republican and No Labels Parties held open Primaries.

This report shows both the ballots selected by unaffiliated voters and ballots voted by unaffiliated voters. The difference is because voters may have selected a party ballot but chose not to vote it.

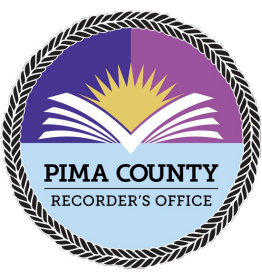

***** Redline:** The Early Election Board rejected the Ballot Affidavit for containing something other than a 2026 PRIMARY ELECTION ballot and were removed from the turnover receipt. Voters were informed by the Recorder's Office.
