Marana Resolution No. 2025-121 approves and authorizes the mayor of Marana to execute a lease and development agreement with Marana Urban LLC for the lease and development of approximately 19 acres of town-owned property located east of Marana Main Street and north of Civic Center Drive. This development agreement was negotiated as the result of an RFP process and of Marana Resolution No. 2025-111 adopting a notice of intent to enter into a retail development tax incentive agreement for the Project. The Lease and Development Agreement provides incentives for development, including an estimated \$84 million in certain infrastructure reimbursements.
